### **Regulation 3.1 - Categories of Members & Subscriptions (Dues)**

(a) **Full Members (associations)**, as defined in the Constitution [as “any national, state, provincial, territorial, community or area Ranger association, which is properly constituted and registered as a body corporate in accordance with local requirements.”] - Subscription (Dues) of USD200. May be waived by the Board.

(b) **Provisional Members (associations)**, as defined in the Constitution [as “An individual Ranger or group of Rangers from a nation, State province, Territory, community or area where there is no established Ranger association.” - No Subscription (Dues).

(c) **Associate Members** as defined in the Constitution [as “Any individual or group who may further the cause of the Company or of protected areas.”], provided that this category is only available to groups or individuals with a direct relationship to rangers or protected areas. Subscription (Dues) of annually of USD50 for groups and USD20 for individuals. May be waived by the Board.

(d) **Honorary Members**, as defined in the Constitution [as “Any individual or group who has made a significant contribution to the Company [IRF], to any Full Member of the Company [IRF] or in the field of conservation, as recognised by the Board.”] - No Subscription (Dues)

(e) **Supporting Members**, defined as businesses of any kind and groups or individuals supporting the IRF, but not directly related to rangers or protected areas - Subscription (Dues) annually of USD100 for businesses, USD50 for groups, and USD 20 for individuals.

(f) **Life Associate Members**, groups or individuals who meet the criteria for Associate Member and who make a general donation to the IRF of at least USD5,000.

(g) **Life Supporting Members**, businesses, groups, or individuals who meet the criteria for Supporting Member and who make a general donation to the IRF of at least USD5,000.
